**PROCESS FOR FILLING ONLINE EXAM FORMS**  
**STUDENT INTERFACE**

1. The students have already received the username and password from the institute. In case of difficulty please write a email to office co-ordinator.

4. Choose the institute and enter the username and password.
5. Click on "Examination Form" tab.
6. Accept the primary information of the student essential for printing further documents.
7. If there is no problem with the information click on accept button. If there is a problem enter the reason for rejection and click on the reject button.
8. Then proceed to accept the forms irrespective of whether you **accept or reject** the personal information. (Institute to make changes in consultation with SIU)
9. Acceptance for Examination form is separate for each semester.
10. **Please check the subjects of each semesters before accepting the examination form.**

- **Payment for Internal and External Backlog fees from EVEN 2025 exam season is online. Student should pay the amount within the registration process on Student Portal.**
  - **Students will not deposit fees with institute Bank Account and Account Department.**
11. When you are accepting online examination form you can check your Aadhar Card and NAD details. If you have any problem contact your concerned coordinator immediately.
