#### LESSONS FOR PUBLIC SAFETY AND DISASTER MANAGEMENT IN INDIA: THE **ODISHA TRAIN DISASTER**

A catastrophic disaster leaves behind many lessons that can be imbibed and help prepare for the future. Train accidents form one such deadly disaster that causes irreparable consequences. It becomes pertinent to implement the lessons learnt at the earliest and prevent future mishaps. Owing to technological and infrastructural development, the accidents per million train kilometres have reduced considerably from 0.1 in 2013-14 to 0.03 in 2021-22. However, it must be borne in mind, that one human error can cost hundreds of lives.

Odisha ranks first in the Disaster Risk Index. which enables the calculation of the average risk of deaths per area. Thus, making it the most vulnerable state in India. However, the State Disaster Management Authority (OSDMA)'s efforts during the COVID-19 pandemic have proved itself to be wellequipped in the area of disaster management. Odisha has developed an effective community-level system that sprang into action while dealing with the after- effects of tropical cyclones and received recognition from the United Nations for the same. The tragic train accident that took place on June 2, 2023, in the Balasore district of Odisha was one such instance where the emergency response and relief efforts played a significant role in mitigating the impact.

However, there were several concerns to be addressed. When it comes to preventing such accidents, public safety should be the top priority but it is often overshadowed by less crucial subjects such as policy decisions fulfilling a political agenda. The Rashtriya Rail Sanraksha Kosh (RRSK)'s aim is to ensure preventive and predictive maintenance of Railway assets, and unfortunately, it has been underfunded since its inception. Additionally, the existing funds are not effectively utilised. There has been a shift from key focus areas, i.e., the upgradation of tracks and relevant technology to launching new trains. This will create an additional burden on the already congested railway line system. Moreover, the involvement of the Central Bureau of Investigation (CBI) in the present case is a dereliction of responsibility on behalf of the government.

The root cause of the accident was identified as an error in the electronic signals. These circumstances call for action towards ensuring that 'public safety' is the highest priority of the railways and the

government. Before expanding the scale of operations, it is crucial to address the existing flaws in the system. The CBI arrested three employees from the railway on July 7, 2023. This measure may be indicative of holding concerned parties accountable, however, the necessary steps to be taken do not end here. It becomes essential to adhere to the protocol mandatorily, addressing maintenance-related concerns at the earliest, and avoiding inordinate delay by bringing in mechanisms to deal with congestion. The varying several factors are interlinked with each other and should have a common aim, i.e., public safety.

The Odisha train disaster is a reminder that although the number of accidents has decreased, such accidents still unfold in the state and the repercussions prove to be deadlier and more drastic with every passing accident. There is a need for efficient collaboration amongst the concerned authorities and stakeholders to mitigate the possibility of such disasters from occurring in the first place. A voicing concern towards public safety and crisis preparedness must echo from civil society groups as well.




